Call to Order

Executive Director Jody Reeves reviewed the year's activities with the membership. Jody attended the ACTE Visions Conference in Las Vegas this year. Georgia was well represented at Visions. The LEAD CTAE Class and CTSO students, along with 200 attendees participated in the Legislative Day at the Capital. There were three winners from Georgia recognized at the Region II Conference in Virginia Beach with one National ACTE winner. Georgia had good representation at ACTE's National Policy Seminar in Mach. At NPS, the Georgia delegation met with elected officials on Capital Hill to advocate for Perkins funding. Jody also attended several economic development events. Things continue to rebound from COVID.

Special Recognition

Business Manager Cynthia Greene was brought to the stage by Matthew White and recognized for her hard work and dedication to GACTE. She is retiring as Business Manager in June. Justin Arthur was hired as GACTE Event Coordinator.

Approval of Minutes

The minutes from the June 15, 2022, Members Annual Business Meeting were presented by Secretary Debra Lary. Financial Report

Bylaws Committee

By-laws committee chairperson Debra Lary reviewed two proposed by-laws changes. Proposed by-law changes were posted on the GACTE web site 30 days prior to voting as specified in article 14 of the by-laws. Proposed by-laws changes were also added to the conference app and projected on the auditorium screen for members to review. Proposed changes were voted on by the membership and both were approved. Updated by-laws will be posted on the GACTE website following the GACTE Conference.

Nominating Committee

Patrick Mahaffey gave the nominating committee report. Nominations opened for President-Elect and Treasurer January 2023 and closed April 30, 2023. There was one nominee for President-Elect, which was Susan Hall. Susan Hall was voted as President-Elect by acclamation. There was one nominee for Treasurer, which was Cheryl Deas. The committee reports were accepted and approved by the Assembly of Members with all members in favor. Matthew announced the new President-Elect, Dr. Cassandra Washington. Installation of officers was conducted by GACTE Past-President Bethany Gilliam.
